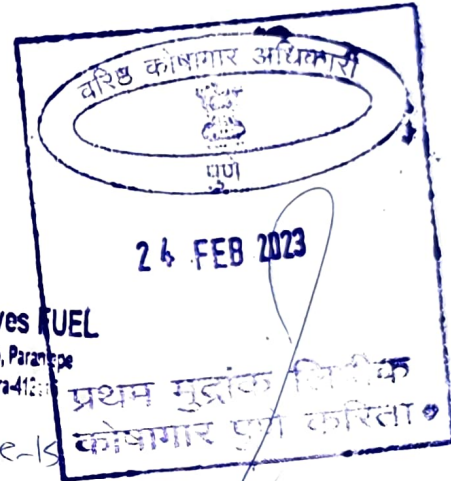



### **Article IV**

#### **Implementation**

## ARTICLE I: PURPOSE

This Memorandum of Understanding (MoU), subject to the Rules and Regulations both the institutions is entered into between and *Arts Science & Commerce College, Indapur, and Shardabai Pawar Mahila ACS College, Shardanagar*, for the purpose of -

- 1.1 To establish a mutually beneficial relationship based on academic and scientific cooperation between the two Parties in terms of collaborative programs and other academic exchanges.
- 1.2 Facilitating joint collaborative research works between students, faculty and staff of the two institutions through specific MoU related to each of the elaborated activity.
- 1.3 Utilization of sophisticated facilities in both institutions and may joint research collaboration.
- 1.4 To share experiences and expertise concerning administration and management of both the organizations through visits and/or online seminars.
- 1.5 To encourage any other activities that both the parties agreed to be a mutual benefit.

## ARTICLE II: AREAS OF COLLABORATION

The scopes of collaboration under this MoU include the following:

- 2.1 Faculty members/scientists of both the Parties may conduct research in either institution with prior approval of their parent institutions.
- 2.2 Both Parties shall endeavour to organize joint seminars, colloquium and other academic and outreach programs.
- 2.3 Both Parties shall apply for collaboration projects jointly to National and International funding agencies.
- 2.4 Both Parties shall endeavour to exchange relevant information in academics.
- 2.5 Exchange of faculty/ students to have first-hand information.
- 2.6 Arrange expert lectures online/ offline for the students of both the institutions.
- 2.7 Exchange ideas about respective subject in imparting employable skills to the students.

**ARTICLE III: GENERAL CONDITIONS**

- a) The aforementioned scope and areas of cooperation shall be realized by means of mutual consultation and exchange of relevant information between the appropriate institutional officials/departments/divisions of the two Parties.
- b) Neither Party nor its personnel shall be considered as an official, employee, representative or joint partner of the other Party. Neither Party shall enter into contract or any other agreement on behalf of the other Party.
- c) Both Parties subscribe to the policy of equal opportunity and shall not discriminate on the basis of gender, age, disability, race, color, religion, marital status, veteran's status, national or ethnic origin, or sexual orientation.
- d) Any activity to be taken up shall be completed within a stipulated time as agreed upon by the Parties.
- e) This MoU will provide the foundation and framework for later particular project(s)/program(s), developed by academic and administrative units/departments of both Parties for which a separate MoU will be signed.
- f) This MoU sets forth the intentions of the Parties to foster collaboration and cooperation in areas of mutual interests without legally binding commitments.
- g) If both Parties later agree to undertake specific joint projects with legally binding obligations, separate written agreements for such project(s) shall be made with mutual consent on each Party's contributions, responsibilities, and financial implications.



## 1. MODE OF OPERATION

Each Party shall designate a coordinator or a group of persons for coordinating and carrying out any activity of mutual interest.

## 2. FINANCIAL COMMITMENT

a) Nothing in this MoU shall be deemed a commitment or obligation of funds from either Party. Financial implication, if any, for carrying out any activity shall be negotiated and agreed upon in writing by the Parties through a separate agreement.

b) The host Party will waive application fees, entrance fees, and tuition fees of the exchange students up to 50 %. Transportation, accommodation, food and other personal costs, etc. will be the personal responsibilities of the students themselves.

However, the host Party may charge an amount for providing a laboratory, library, internet facilities, etc. The amount will be intimated at the time of making an offer.

## 3. COMPLIANCE

Both Parties shall be responsible for compliance with and implementation of respective national, state, regulatory and/or licensing agencies during the term of MoU, which shall be governed by and construed in accordance with the applicable laws and statutes of the respective Parties, and shall be contingent upon both Parties for securing and maintaining all necessary accreditation, approvals and/or licenses.

## 4. PROPERTY RIGHTS

Both Parties shall jointly share the outcome of collaborative research works in terms of authorship, patent, copyrights, and other intellectual property rights.

## 5. ASSIGNMENT

Neither Party shall be permitted to assign or transfer any interest in this MoU without the prior written approval of the other Party.

## 6. LEGAL STATUS

a) This MoU is not to be construed as creating legal relationship between the Parties. It is only a statement of intent to foster genuine and mutually beneficial cooperation.

## 7. TERM OF AGREEMENT

This MoU shall become effective from the date of signing by the official representatives of the Parties and shall remain in force for a period of five (5) years. The MoU may be renewed and extended upon mutual agreement prior to the date of expiry.

**8. TERMINATION**


a) Termination of this MoU may be affected upon deliberation by both Parties. Either Party has the right to terminate the MoU by giving six-month notice in writing to the other Party.





- c) Both Parties subscribe to the policy of equal opportunity and shall not discriminate on the basis of gender, age, disability, race, color, religion, marital status, veteran's status, national or ethnic origin, or sexual orientation.
- d) Any activity to be taken up shall be completed within a stipulated time as agreed upon by the Parties.
- e) This MoU will provide the foundation and framework for later particular project(s)/program(s), developed by academic and administrative units/departments of both Parties for which a separate MoU will be signed.
- f) This MoU sets forth the intentions of the Parties to foster collaboration and cooperation in areas of mutual interests without legally binding commitments.
- g) If both Parties later agree to undertake specific joint projects with legally binding obligations, separate written agreements for such project(s) shall be made with mutual consent on each Party's contributions, responsibilities, and financial implications.

**1. MODE OF OPERATION**

Each Party shall designate a coordinator or a group of persons for coordinating and carrying out any activity of mutual interest.

**2. FINANCIAL COMMITMENT**

- a) Nothing in this MoU shall be deemed a commitment or obligation of funds from either Party. Financial implication, if any, for carrying out any activity shall be negotiated and agreed upon in writing by the Parties through a separate agreement.

- b) The host Party will waive application fees, entrance fees, and tuition fees of the exchange students up to 50 %. Transportation, accommodation, food and other personal costs, etc. will be the personal responsibilities of the students themselves.

However, the host Party may change an amount for providing a laboratory, library, internet facilities, etc. The amount will be intimated at the time of making an offer.





### 3. COMPLIANCE

Both Parties shall be responsible for compliance with and implementation of respective national, state, regulatory and/or licensing agencies during the term of MoU, which shall be governed by and construed in accordance with the applicable laws and statutes of the respective Parties, and shall be contingent upon both Parties for securing and maintaining all necessary accreditation, approvals and/or licenses.

### 4. PROPERTY RIGHTS

Both Parties shall jointly share the outcome of collaborative research works in terms of authorship, patent, copyrights, and other intellectual property rights.

### 5. ASSIGNMENT

Neither Party shall be permitted to assign or transfer any interest in this MoU without the prior written approval of the other Party.

### 6. LEGAL STATUS

- a) This MoU is not to be construed as creating legal relationship between the Parties. It is only a statement of intent to foster genuine and mutually beneficial cooperation.

### 7. TERM OF AGREEMENT

This MoU shall become effective from the date of signing by the official representatives of the Parties and shall remain in force for a period of **five (5) years**. The MoU may be renewed and extended upon mutual agreement prior to the date of expiry.

1. Objective:

2. Period of MOU:

The College further authorises GTT to share the above information with NASSCOM Foundation/ Barclays to get in touch with the students for updating them about various job fairs, placement drives etc, and to seek feedback of the program.
- c. It would be the responsibility of the College to ensure that proper publicity of the Program is made through College website.
- d. To encourage the Students to register for the Program by informing them about the benefits of the program.
- e. To provide all the support services and facilities to GTT during the conduct of the said Training Program.
- f. To coordinate with GTT and facilitate conduct of all the assessments including the assessment to be conducted by the external agency (if any) identified by GTT, as per schedule communicated by GTT.



**4. Roles & Responsibilities of GTT:**

- a. GTT shall be responsible to provide access to employability enhancement related activities through blended learning model including use of Career Clap.
- b. GTT will arrange for assessment of its own and also arrange external assessment as required.

**5. Other Terms & Conditions:**

- c. Program Coordinator to be appointed by college

- e. The College shall not write/publish any material or use any logos/names of GTT/ NASSCOM Foundation/ Barclays in any of the publications without prior written consent and approval from GTT.

**6. Commercial:**

This Training Program is free of cost. GTT shall not charge any fees on whatsoever account/name from the students or the College for conducting the aforesaid training program.

**7. Certification:**

E-Certificates shall be awarded by GTT to the students on successful completion of the training and clearing of the assessment held post completion of the training program.

**8. Limitations and Warranties:**

Both parties agree that it would be their endeavour to prevent any liability arising out of default or non-compliance of the MOU terms by the other party.

**9. Termination:**

- a. Both parties can terminate the MOU with a prior written thirty (30) day notice on default of terms of non-adherence to any condition or responsibilities by the other party as outlined in this MOU in case such default is not rectified within such 30 days.
- b. Both parties also agree that it would be their professional endeavour that despite any termination of the MOU, progress would continue, without any prejudice to the ongoing Training Programs, which would be without any hindrance and would be progressed for completion.

**10. Entirety & Amendment:**

- b. Already in its possession other than as a result of a breach of this clause; or in the hands of the public other than as a result of a breach of this clause.
- c. In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so as to enable the other party to seek a timely protective order or any other appropriate relief. If such an order or other relief cannot be obtained, the party being required to make such a disclosure shall make the disclosure of the Confidential Information only to the extent that is legally required of it and no further.
- d. Both parties agree not to deal directly or enter into any business agreement with any of the partners or associates or customers of either party during the term of the agreement and also after the agreement have been terminated, not earlier than two years from the date of termination.

**13. Force Majeure:**

- a. Neither party to this MOU shall be liable for any failure or delay on its part in performing any of its obligations under this MOU, if such failure or delay shall be result of or arising out of Force Majeure conditions and, provided that the party claiming Force Majeure shall use its best efforts to avoid or remove such cause of non-performance and shall fulfil and continue performance hereunder with the utmost dispatch whenever and to the extent such cause or causes are removed.
- b. Any extraordinary event, which cannot be controlled by the parties, shall for the purpose of this MOU be considered as a Force Majeure event. Such events include acts of God, acts or omissions of any Government or agency thereof, compliance with rules, regulations or order of any Government Authority. Provided however, if either party claims that existence of any of the aforesaid conditions is delaying or disabling the performance by said party of its obligations under this MOU, such party shall give immediate notice to the other party of the existence of such conditions whose existence are claimed to delay or disable the performance of obligations as aforesaid.

**14. Jurisdiction and Arbitration:**

- a. In the event of any dispute or difference between the Parties hereto, the courts in Pune alone shall have exclusive jurisdiction to try any matter arising between the Parties here-to and accordingly both the Parties shall submit to the exclusive jurisdiction of courts in Pune, Maharashtra.
- b. Any dispute arising out of, in relation to or in respect to this MOU shall be settled through mutual consultation and agreement, by the Parties to this MOU. In case a settlement is not arrived at within fifteen (15) days of reference, the dispute/s shall be referred to a sole arbitrator to be appointed in accordance to the Arbitration and Conciliation Act, 1996 as amended from time to time. - b. Already in its possession other than as a result of a breach of this clause; or in the hands of the public other than as a result of a breach of this clause.
- c. In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so as to enable the other party to seek a timely protective order or any other appropriate relief. If such an order or other relief cannot be obtained, the party being required to make such a disclosure shall make the disclosure of the Confidential Information only to the extent that is legally required of it and no further.
- d. Both parties agree not to deal directly or enter into any business agreement with any of the partners or associates or customers of either party during the term of the agreement and also after the agreement have been terminated, not earlier than two years from the date of termination.

**13. Force Majeure:**

- a.
